#### R21-1: NAAQS Update (January 1, 2020 through June 30, 2020)

Although proposed, on final adoption, the Board concluded that the 1997 one-hour NAAQS no longer applied within Illinois. National Ambient Air Quality Standards, USEPA Regulations (through December 31, 2012), R13-11 (July 25, 2013), slip op. at 48-49. The Board later removed the 1997 eight-hour NAAQS because it was revoked as to all areas in Illinois. National Ambient Air Quality Standards, USEPA Amendments (January 1, 2015 through June 30, 2015, August 26, 2015, October 26, 2015, November 19, 2015, December 18, 2015), R16-2 (Mar. 3, 2016), slip op. at 7. The Board did not remove appendices H and I although they no longer supported an applicable NAAQS.
