## Good morning, Jonathan:

Thank you for identifying this problem with the proposed definition "commercial interior adhesive."

In this rulemaking, the Board is imposing a VOM-content limit (219.204(r)(2)(N)) on commercial interior adhesives, *i.e.*, the materials used in bonding passenger cabin interior components. However, this rulemaking is not imposing any requirement—of fireworthiness or otherwise—on the cabin components themselves. Your question revealed that the definition of "commercial interior adhesive," as it currently reads, incorrectly suggests that the Board's emission limits would require that the cabin components comply with FAA fireworthiness requirements. Those FAA requirements stand on their own and are not intended to be incorporated by reference into these Board rules.

To clarify the definition, we suggest the following changes to 211.1327:

"Commercial interior adhesive" means materials used in the bonding of passenger cabin interior components **that are subject to . These components must meet** the Federal Aviation Administration fireworthiness requirements.
