#### **FACTS**

- 1. That Respondent, William Wilburn is the present owner and/or operator of property located in Groveland Township, LaSalle County, Illinois.
- 2. That said facility is an open burn and open dump site, operating without an Illinois Environmental Protection Agency Permit, and is designated with Site Code No. 0998145008. Said facility is commonly known to the Agency as the Wilburn Property.
- 3. That the Respondent has owned and/or operated said facility since June 10<sup>th</sup>, 2010.
- 4. That on March 16, 2021, Lauren Grumieaux and Brooke Schumacher of the LaSalle County Department of Environmental Services and Land Use, under the authority of the Illinois Environmental Protection Agency, inspected the above described facility. A copy of the inspection reports setting forth the results of such inspections are attached hereto and made a part hereof.

5. On the basis of direct observations of Lauren Grumieaux and Brooke Schumacher of the LaSalle County Department of Environmental Services and Land Use, it has been determined that the Respondents have caused or allowed open dumping at the above described facility in a manner which results in the following occurrences:

#### CIVIL PENALTY

- 6. Pursuant to 415 ILCS 5/42 (b) (4), formerly III. Rev. Stat. 1991, ch. 111 ½, par. 1042 (b) (4), Respondent herein is subject to a civil penalty of Fifteen Hundred Dollars (\$1500.00) for each violation specified above in Paragraph 5(b) for a total of Six Thousand Dollars (\$6000.00). Additionally, should Respondents elect to petition the Illinois Pollution Control Board under the review process described herein below, and if there is a finding of the violation alleged herein, after an adjudicatory hearing, Respondents shall be assessed the associated hearing costs incurred by the Illinois Environmental Protection Agency and the Illinois Pollution Control Board, in addition to the Fifteen Hundred Dollar (\$1500.00) statutory penalty for each finding of violation.
- 7. If you acknowledge the violations cited herein above, the civil penalty specified above shall be due and payable no later than thirty-five (35) days from the date of service hereof. If you do not petition the Illinois Pollution Control Board of review of this Administrative Citation within thirty-five (35) days of service hereof or if you elect to contest this Administrative Citation, any judgment rendered against you shall specify the due date of the statutory civil penalty and any costs assessed against you.
- 8. When payment is made, one certified check or money order for (\$3,000.00) shall be made payable to the **LaSalle County Treasurer** and mailed to:

Also, please complete and return the enclosed Remittance Form, along with your payment, to assure proper documentation of payment.

9. If any civil penalty imposed by the Illinois Pollution Control Board is not paid within the time prescribed in the order, interest from such penalty will be assessed for the period from the date payment is due until the date payment is received. If any civil penalty, by reason of acknowledgment, default or finding after the adjudicatory hearing is not paid when due, the LaSalle County State's Attorney may initiate proceedings in Circuit Court to collect said civil penalty. In addition to the previously assessed civil penalty, interest and hearing costs of the Illinois Pollution Control Board, if any, the State's Attorney's Office will seek to recover their costs of litigation.

#### NARRATIVE INSPECTION REPORT DOCUMENT

#### GENERAL REMARKS

On March 16<sup>th</sup>, 2021 an open dump and open burn re-inspection was conducted at 205 E Broad St., Rutland, IL by Lauren Grumieaux and Brooke Schumacher, representing the LaSalle County Environmental Services and Land Use Department, under the delegation authority of the Illinois Environmental Protection Agency. The property is owned by William Wilburn and Robert Durbin resides on site.

Weather conditions on March 16<sup>th</sup>, 2021 were overcast and 37 degrees F. Winds N at 3mph.

Brooke and I arrived at the site at 1:53 PM and began the inspection.

After parking the vehicle, we noticed Mr. Robert Durbin was outside tending a fire, at the time of our arrival. While making our way on to the property, we documented a stack of wooden pallets, construction debris, domicile waste and other accumulated debris along the drive way. (Photo#1) After a short introduction, I explained to Robert that Brooke and I were on site for the re-inspect of the property. Robert stated that he had been working to clean up the property but it was slow moving.

Starting on the southern end of the property, Brooke and I documented the area. A pull behind trailer was filled with household debris. A garage door, CED's, furniture, and scrap metal was strewn throughout the yard. Next, we viewed the burn pile. I documented domicile waste, construction debris, furniture, box, fans, plastics, metal, carpet, metal drums and other accumulated debris. (Photos #2) I noted that not much had been removed from the burn pile since the previous inspection. Continuing on, we turned to the north. More metal, furniture, house hold items, tires, domicile waste, and an accumulation of debris was viewed. (Photo#3) Making our way to the burn barrel, Brooke and I noted that demolition debris and pieces of wood furniture were being burnt. (Photo#4 & #5) Near the burn barrel was a partly melted blue plastic barrel. Food containers, plastic, cans, kid's shoes, glass, and charred domicile waste had been recently burnt. (Photo#6) While viewing the area, many small burn piles were found throughout the site. I explained that the burning of waste is prohibited and moving forward, domicile waste would need to be disposed of at a landfill.

Moving to the south, little change was made in the area. (Photo#7 & #8) Turning to the west we viewed the font of the home. The white goods, scrap metal and wood had been removed from the area. Robert stated that he had been working to clean the area near the home. Continuing on, more waste, food scrapes and furniture were observed. (Photo#9 & #10) Looking to the east, I documented construction and demolition debris, large piles of treated wood, tires, pieces of furniture, kid's toys, plastics, grills, and an accumulation of other house hold items. (Photo#11 & #12) Once Brooke and I finished walking the site, I asked for any receipts he would have received from the recycling center. Robert stated that he did have receipts and went into the house to retrieve them. After a few minutes, he returned and stated that he wasn't able to find them at the time and would bring them into the

office once they turned up.

Brooke and I then thanked Mr. Durbin for his time and concluded the inspection at 2:24 PM.


