- 10) Has JCAR issued a Statement of Objections to this rulemaking? No
- Differences between proposal and final version: In first-notice comments, participants, including IEPA, requested changes based on testimony received at hearing. The Board agreed to many clarifying changes as well as strengthening provisions for public participation (in 845.240, 845.260), adding a location restriction requiring a floodplain-specific demonstration (845.340), additional requirements concerning fugitive dust complaints (845.500), addition of public participation in the Alternative Source Demonstration process (845.650), and requiring the analysis of transportation alternatives when closing a surface impoundment by removal (845.710). The Board discusses these changes in detail in its second-notice opinion. The Board has also changed references to "effective date of this part" to a date specific: April 21, 2021.

 Due to an extended second-notice period requested by JCAR, certain compliance dates have been pushed back one month. At adoption, the Board makes a number of non-substantive changes proposed by JCAR

- 13) Will this rulemaking replace an emergency rule currently in effect? No
- 14) Are there any other rulemakings pending on this Part? No
- Summary and Purpose of Rulemaking: Section 22.59(g) of the Environmental Protection Act (Act) (415 ILCS 5/22.59(g), amended in P.A. 101-171 (eff. July 30, 2019) requires IEPA to develop rules establishing construction permit requirements, operating permit requirements, design standards, reporting, financial assurance and closure and post-

closure care requirements for coal combustion residuals (CCR) surface impoundments. CCR is commonly referred to as coal ash and IEPA has identified 23 power plants in the state that used coal as a fuel source and may be impacted by this rule. When coal is burned at power plants, CCR is formed. IEPA has identified 73 CCR surface impoundments at power generating facilities in the state. The proposed rule fulfills IEPA's statutory obligation to propose new CCR rules to the Pollution Control Board by March 30, 2020. The proposed rules are intended to protect the groundwater within the state of Illinois. An additional purpose of the proposed rules is to adopt the federal CCR rules in Illinois and obtain federal approval of Illinois' CCR surface impoundment program. Further, the proposed rules seek to ensure meaningful public participation in the permitting process of CCR surface impoundments.
