MOTION FOR EXTENSION OF TIME

The Illinois Environmental Protection Agency ("Illinois EPA" or "Agency"), by and through its attorney, hereby submits its Motion for Extension of Time and requests a 90-day extension of time, up to and including Thursday, September 23, 2021, to file its recommendation concerning the Petition of Midwest Generation LLC for Adjusted Standards From 35 Ill. Admin. Code, Part 845 (Joliet 29), stating as follows:

- On May 11, 2021, Petitioner filed its Petition for Adjusted Standards from 35 Ill.
 Admin. Code, Part 845.
- 2. The Agency's recommendation must be filed with the Board within 45 days after the filing of the petition, *i.e.*, by June 25, 2021. 35 Ill. Admin. Code. 104.416 Agency Recommendation and Petitioner Response.
- 3. On May 11, 2021, eight petitions for adjusted standards and three petitions for variances were filed with the Board concerning Part 845. Many of these petitions seek adjusted standards or variances for multiple CCR surface impoundments.
- 4. The Agency is currently reviewing these petitions, but, due to the number of petitions received and number of CCR surface impoundments at issue, the Agency anticipates it will need additional time to review and develop recommendations.

5. The Agency has conducted an initial review and, based on certain factors, including

timing and potential threat to the environment, has determined which petitions it believes should

be addressed first.

6. Based on the Agency's review and the number of recommendations the Agency

must complete, the Agency requests the Board extend the deadline to file its recommendation

concerning the Petition of Midwest Generation LLC for Adjusted Standards from 35 Ill. Admin.

Code, Part 845 (Joliet 29), to September 23, 2021.

7. Counsel for the Agency contacted counsel for Midwest Generation LLC, who

indicated they have no objection to the requested extension of time.

WHEREFORE, the Agency requests the Illinois Pollution Control Board grant its Motion

for Extension of Time and grant the Agency an additional 90 days, up to and including September

23, 2021, to file its recommendation with the Board.
