This notice is published pursuant to 415 ILCS 5/28.1 and 35 III. Adm. Code 104.408 to inform the public of the submittal by Ameren Energy Medina Valley Cogen, LLC (Ameren), 1901 Chouteau Avenue, St. Louis, Missouri 63103, of a Petition for an Adjusted Standard with the Illinois Pollution Control Board (the, "Board") pursuant to 35 Ill. Adm. Code 104.402 on May 11, 2021.

Ameren's petition, which has been assigned the docket number AS 2021-007, requests an adjusted standard from 35 III. Adm. Code, Part 845 for its Hutsonville D site. Specifically, Ameren requests adjustments to all sections of 35 III. Admin. Code Part 845, except for the provisions of Part 845, Subpart H: Recordkeeping, Section 810, Publicly Accessible Internet Site Requirements, and Subpart I: Financial Assurance, effective April 21, 2021.

In its petition, Ameren requests that the Board grant the fol-

lowing adjusted standard:

(1) Ameren shall continue to comply with the provisions of the Board's Site-Specific regulations, as promulgated by the Board in 35 III. Admin. Code Part 840.

(2) Unless, otherwise provided below, the provisions set forth in the Board's new Part 845, 35 III. Admin. Code Part 845,

shall now be applicable to Hutsonville D.

(i) Ameren shall post all record keeping documents required pursuant to 35 III. Admin. Code 840.116 on an Internet Website maintained in accordance with 35 III. Admin. Code 845.810.

(ii) Ameren shall maintain financial assurance for Hutsonville D, as required under 35 III. Admin. Code 845, Subpart 1. Ameren's Hutsonville D site is located at 15142 East 1900 Avenue, Hutsonville, Crawford County, Illinois ("the facility"). The facility generated electricity for more than sixty years but has been inactive in terms of generating electricity since December 2011 and is now entirely decommissioned, with all of its infrastructure removed, with the exception of two remaining combustion residuals surface impoundments ("CCRSI"). Hutsonville D was closed in 2013 with pursuant

to the authority and approval of the State of Illinois.

The closure of Hutsonville D occurred pursuant to the authority and approval of the IEPA in accordance with 35 III. Admin. Code Part 840, the site-specific regulation adopted by the Board in R09-21 for the closure of Hutsonville D. Ameren completed capping Hutsonville D in January 2013 and sent a letter to the IEPA on January 30, 2013 documenting completion of closure for Hutsonville D consistent with the IEPA's approved closure plan. In accordance with Part 840 and the approved post-closure plan, Ameren reports annually to IEPA with regards to post-closure care of Hutsonville D.

Any person may cause a public hearing to be held in the above-described adjusted standard proceeding by filing a hearing request with the Illinois Pollution Control Board within 21 days after the date of the publication of this notice. The hearing request should indicate the docket number for the adjusted standard proceeding, as found in this notice. The hearing request must be mailed to the Clerk, Illinois Pollution Control Board, 100 W. Randolph Street, Suite 11-500, Chicago, Illinois 60601, or filed electronically through COOL, located on the Board's website (www.ipcb.state.il.us).
