## **HEARING OFFICER ORDER**

The previously scheduled telephonic status conference for May 20, 2021, was cancelled by agreement and rescheduled to the date and time noted below. It is noted that the Board Order of December 5, 2019, held that if the petitioner in the consolidated case PCB 16-19 files a petition for alternative thermal effluent limitations the stay previously granted in this matter will be in effect until the Board reaches its final decision on the petition for alternative limitations.

The petitioner in PCB 16-19 did file two petitions for alternative effluent limitations and the Board on its own motion consolidated the petitions and accepted them. <u>Midwest Generation</u>, <u>LLC, v. IEPA</u>, PCB 38 & PCB 20-39 (Feb. 6, 2020). Therefore, this matter's stay continues until the Board decides the aforementioned petitions.

Note that the Board's order of July 25, 2019 consolidated this petition with PCB 16-19 for purposes of the hearing. <u>INEOS Joliet, LLC, v. IEPA, PCB 16-24</u> (July 25, 2019).

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on July 8, 2021, at 10:30 a.m. The status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.
