OPINION AND ORDER OF THE BOARD (by A. Palivos):

On March 3, 2020, Michael J. Korman (Korman) filed a complaint against the Illinois Department of Transportation (IDOT). The complaint concerns IDOT's construction project which will expand the Willow Road overpass over Leigh Road and the SOO Line in Glenview, Illinois. On August 5, 2020, IDOT filed a demand for a bill of particulars. Korman responded to this demand on August 17, 2020. On September 11, 2020, IDOT filed a motion to strike Korman's bill of particulars. Korman responded to this demand on September 24, 2020. Subsequently, IDOT filed a motion to strike Korman's second bill of particulars on October 7, 2020.

On April 1, 2021 the Board denied both IDOT motions to strike a bill of particulars. However, the Board found that - considered together - the two bills did not particularize the March 3, 2020 complaint sufficiently to meet the requirements of the Act and Board regulations and did not sufficiently advise IDOT of the claim against it. Consequently, the Board directed Korman to file an amended complaint addressing these requirements by Monday, May 3, 2021.

The Board did not receive an amended complaint by May 3, 2021. As such, the Board now dismisses this case and closes the docket.

IT IS SO ORDERED.

Section 41(a) of the Environmental Protection Act provides that final Board orders may be appealed directly to the Illinois Appellate Court within 35 days after the Board serves the order. 415 ILCS 5/41(a) (2018); see also 35 Ill. Adm. Code 101.300(d)(2), 101.906, 102.706. Illinois Supreme Court Rule 335 establishes filing requirements that apply when the Illinois Appellate Court, by statute, directly reviews administrative orders. 172 Ill. 2d R. 335. The Board's procedural rules provide that motions for the Board to reconsider or modify its final orders may be filed with the Board within 35 days after the order is received. 35 Ill. Adm. Code 101.520; see also 35 Ill. Adm. Code 101.902, 102.700, 102.702. Filing a motion asking that the Board reconsider this final order is not a prerequisite to appealing the order. 35 Ill. Adm. Code 101.902.
