Hope all is well.

As I was closing this file, I ran across a few issues in the text of the official paper Code version that I wanted to bounce off you:

- 1) 310.106(a)(1)(C)(i): "fascimile" should be "facsimile". It was in existing text so we both missed it.
- 2) 310.106(b)(2), "NPDES program": Right before the Board Note, should "pretreatment." be "pretreatment)."?
- 3) 310.106(b)(7)(C), first line: Should "section" be capitalized?
- 4) 310.106(b)(8)(A), in the first column of the chart, should the period after "310.612" in the parenthetical citation be removed?
- 5) 310.106(b)(8)(C), Board note, penultimate line: Would "recipient when" work in place of "recipient where"?
- 6) 310.110, "Authorization to Discharge", Board Note: Should the comma be placed outside the closing quotation mark after "permit"?
- 7) 310.110, "CWA", just before Board Note: Should the citation end "et seq.)." since "seq" is an abbreviation?
- 8) 310.110, "Industrial wastewater": Could this definition be clarified? As written, it's difficult to understand.
- 9) 310.110, "Pretreatment permit", Board Note: Should the comma be placed outside the closing quotation mark after "discharge"?

Also, could the following three background text issues from Sections not in this rulemaking be addressed the next time the Part is open?:

- 1) 310.311(c)(1), 2<sup>nd</sup> line: "though" should be "through".
- 2) 310.351(c), 3<sup>rd</sup> line from bottom: "catagorical" should be "categorical".
- 3) 310.415(a): "permitee" should probably be "permittee" to match the rest of the Part.
