NOTICE OF LIMITED WAIVER OF 120-DAY DECISION DEADLINE

NOW COMES Petitioner, UNITED STATES STEEL CORPORATION ("Petitioner"), by and through its attorneys, HEPLERBROOM LLC, pursuant to 35 Ill. Admin. Code § 101.308(c)(2), hereby agrees to a limited waiver of the statutory 120-day decision deadline in this proceeding until March 31, 2022. In support of this Notice, Petitioner states as follows:

- 1. On May 6, 2013, Petitioner filed a Petition for Review ("Petition") of the Construction Permit with Integrated Processing issued to Petitioner by the Illinois Environmental Protection Agency ("Illinois EPA") on April 1, 2013, for an emission control system for Petitioner's basic oxygen process ("BOP") furnaces at Petitioner's integrated steel mill plant located in Granite City, Illinois.
