HEARING OFFICER ORDER

On December 21, 2021, the Illinois Environmental Protection Agency (IEPA) filed a motion for extension of time to file its Recommendation as to Pond 2. (Mot.). The IEPA requests a 30-day extension to and including January 21, 2022. Mot. at 3-4.

The IEPA reports that additional documentation has been provided by the petitioner for review and "that the additional information obtained from ongoing discussions between the Illinois EPA and Petitioner will result in a more robust and accurate Agency Recommendation to the Board." Mot. at 4. The IEPA states that the petitioner has no objection to the extension of time. *Id*.

The IEPA's motion is granted and its Recommendation is now due on or before January 21, 2022.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on January 13, at 10:00 a.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. The petitioner is to provide a call-in number. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing. Should the parties agree to reschedule the conference call because of the extension, give a date and time if rescheduling is desired.
