
HEARING OFFICER ORDER

On December 16, 2021, all parties participated in a telephonic status conference with the hearing officer. The petitioner reports that it has announced its planned retirement of this station in June 2022 provided it has approval from PJM. As such, it has suspended discussions with the respondent. If approved, it anticipates dismissing this appeal following retirement.

The petitioner stated that it will file an additional waiver of the statutory decision deadline to and including June 30, 2022.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on March 17, 2022, at 9:30 a.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




