The Attorney General has brought a case against Cranbrook Farms, LLC for violating State pollution control rules. On December 30, 2021, the parties filed an agreed modification to a stipulation and settlement the Board had accepted on May 21, 2020. People v. Cranbrook Farms, PCB 17-19, slip op. at 2 (May 21, 2020). The parties agree that a hearing is unnecessary, and in accordance with State law, have requested that the settlement be adopted without holding a public hearing. Any person who would like to comment on, or demand a public hearing on, the stipulation and proposal for settlement may do so by filing a written comment or hearing demand with the Illinois Pollution Control Board within 30 days after the publication of this notice. The written comment or hearing demand must refer to People of the State of Illinois v. Cranbrook Farms, LLC, PCB 17-19, and must be filed with the Clerk of the Illinois Pollution Control Board, 100 West Randolph Street, Suite 11-500, Chicago, Illinois 60601.
