**HEARING OFFICER ORDER**

The parties are advised that this matter has been assigned to the hearing officer identified below. From this date forward, any pleading filed with the Clerk of the Board in this matter must also be served by email on the hearing officer.

On March 10, 2022, the parties participated in a telephone status conference with the hearing officer. Petitioner will submit additional information, and the parties are exploring whether the case may be resolved without a hearing. If no waiver is filed, a hearing may be scheduled for May 17, 2022. The parties agree that a three-day briefing schedule without having received the transcript will suffice. Counsel for petitioner stated that he does not need to receive the administrative record before hearing, so the deadline for the record to be filed is extended to the hearing date. Petitioner will also consider whether to waive the decision deadline to July 14, 2022.

The parties are directed to participate in a telephone status conference with the hearing officer at 2:30 p.m. on April 12, 2022. Petitioner will circulate a conference call number.

The decision deadline is June 23, 2022.
