HEARING OFFICER ORDER

On March 17, 2022, all parties participated in a telephonic status conference with the hearing officer. The petitioner reported that the Board remanded the permit to the Illinois Environmental Protection Agency and lifted the stay on the uncontested conditions. Southern Illinois Power Cooperative v. IEPA, PCB 06-61 (Feb. 17, 2022). At the appropriate time the petitioner will file a motion to dismiss this appeal.

The petitioner stated that it will file an additional waiver of the statutory decision deadline to and including September 16, 2022.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on June 16, 2022, at 10:00 a.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


