Dear Mr. Brown,

Thank you for the opportunity to provide public comment on these draft rules that will address key gaps in Illinois' new coal ash rules, ensuring that coal ash communities and Illinois' water resources are fully protected from dangerous coal ash pollution.

As a concerned Illinois resident, I strongly support:

- 1) Regulatory protections, as drafted, that would ensure polluting coal ash outside of ponds (coal ash in fill areas and other scattered coal ash) is properly cleaned up and no longer a threat to groundwater.
- 2) Regulatory protections for environmental justice communities.
- 3) Regulations requiring monitoring of and mitigation plans for fugitive dust from coal ash.
- 4) Regulations that set a three-month limit on the use of temporary storage piles for coal ash.

Signed with the additional comments below:

At a previous meeting, covering coal ash ponds was offered as a solution for cleaning them up. As you know that is NOT a viable means of protecting ground water, particularly in unlined ponds and there is not evidence of how long a liner protects the environment under these kind of toxins.
