
**HEARING OFFICER ORDER**

On June 23, 2022, all parties participated in a telephonic status conference with the hearing officer. Petitioner reports that it has announced the planned retirement of this station in June 2022, provided it receives approval from PJM. As such, it has suspended discussions with the respondent. If approved, petitioner anticipates dismissing this appeal following retirement.

Petitioner will file an additional waiver of the statutory decision due date to and including January 20, 2023.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on September 22, 2022, at 10:30 a.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




