Illinois Environmental Protection Agency (Water – Tax Certification) – The Board found and certified that 4 Nelson Farms' livestock waste management facilities in Henry County are pollution control facilities for preferential tax treatment under the Property Tax Code (35 ILCS 200/11-10 (2020)).	5-0 roll call vote
