
HEARING OFFICER ORDER

On September 12, 2022, all parties participated in telephonic status conferences with the hearing officer. The parties stated that the depositions are proceeding and requested an additional day to complete depositions. Their request is granted and the deposition cut-off date is now September 21, 2022.

On September 2, 2022, respondent filed a motion for permission to file amended record on appeal. Petitioner may timely file a response. Any motions *in limine* must be filed on or before September 22, 2022, by 1:00 p.m. Any responses must be filed on or before September 26, 2022, by 1:00 p.m.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on September 26, 2022, at 1:00 p.m. The telephonic status conference must be initiated by the petitioner, and provide a call-in number, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




