## ILLINOIS POLLUTION CONTROL BOARD NOTICE OF PROPOSED STIPULATION AND PROPOSAL FOR SETTLEMENT OF ENFORCEMENT CASE

The Attorney General has brought a case against LMS Industries and Top Metal Buyers for violating State pollution control rules. On September 15, 2022, the parties filed a stipulation and proposal for settlement. The parties agree that a hearing is unnecessary, and in accordance with State law, have requested that the settlement be adopted without holding a public hearing.

Any person who would like to comment on, or demand a public hearing on, the stipulation and proposal for settlement may do so by filing a written comment or hearing demand within 21 days after the publication of this notice. The written comment or hearing demand must refer <u>People of</u> the State of Illinois v. LMS Industries, LLC and Top. Metal Buyers, Inc., PCB 21-029, and must be filed with the Clerk of the Illinois Pollution Control Board, 100 West Randolph Street, Suite 11-500, Chicago, Illinois 60601. 
