AMENDED HEARING REPORT

On September 28, 2022, a hearing was held in the above-captioned matter at the James R. Thompson Center, Room 9-040, 100 West Randolph St., Chicago, Illinois 60601.

Attorneys Mr. Daniel J. Deeb and Mr. Alex Garel-Frantzen appeared and participated on behalf of the petitioner, Aqua Illinois Inc. Attorneys Ms. Kathryn Pamerter, Ms. Ann Marie Hanohano and Mr. Christopher Grant appeared and participated on behalf of respondent, Illinois Environmental Protection Agency.

Preliminary Matters

On September 27, 2022, petitioner filed a motion *in limine* (Mot.) seeking to exclude any references, testimony, or argument at hearing relating to the following two documents relative to Additional Condition No. 6: “Email from David Cook dated November 5, 2021 with Kankakee and Iroquois River nitrate data and related emails,” R 000581-000600, and (2) “Kankakee WTP TP01 Nitrate,” R 000602,” because they were only first included in the complete record that was filed on September 23, 2022, and not the prior “Amended Record” filed on August 26, 2022, and September 2, 2022. *See* Mot. at 3-4. Petitioner’s motion was denied at hearing on September 28, 2022. Transcript at 10-11.


Exhibits


