## Kruk Response to RESPONDENT'S REQUESTS FOR PRODUCTION OF DOCUMENTS TO COMPLAINANT

## **REQUESTS FOR PRODUCTION**

1. Produce any report relating to the alleged violation of numeric noise standards in this case, prepared by or for you or any witness identified in your Answers to the District's Interrogatories delivered simultaneously with this Request to Produce.

The numeric measurements have been taken numerous times by Shiner Acoustics and showed continued non-compliance.

Multiple reports prepared by Shiner Acoustics showed noise measurements above allowable limits as taken at 124 Woodland Ave

Shiner Acoustics report dated 07/15/2019 (Exhibit 1 Shiner) which was not disclosed by the district until January 2022 showed measurements and procedures for the testing done on 07/12/2019.

This report showed measurements exceeded Illinois daytime limits in 5 of 9 octaves, see Table 1 of Exhibit 1 Shiner.

Also, see 12/20/2019 (Exhibit 2 Shiner) and 08/15/2018 (Exhibit 3 Shiner) Shiner Acoustics reports showing noise measurements above allowable limits, as well. These reports contain sufficient data and expert opinion to confirm the non-compliance.

Please also note, there are outstanding requests by Kruk to New Trier High School to disclose all sound measurements performed for them to include all procedures and measurements of all equipment tested.

These outstanding reports, once disclosed will need to be reviewed before the Board.

Numerous videos showing night disturbance, most of which have been shared via email with the district are also available and will be presented, as needed.

2. Produce all numeric measurements taken of noise emissions at your property relating to your allegations against the District, including but not limited to descriptions of corresponding measurement techniques and emissions results.

3. Produce all documents in your possession showing a current violation by the District of noise standards pursuant to the procedures outlined in Section 900.103 and Section 910.105 of Title 35 of the Illinois Administrative Code regarding Environmental Protection.
