**HEARING OFFICER ORDER**

On January 12, 2023, the parties reported that complainant has continued to review ongoing correspondence between respondent and the Illinois Environmental Protection Agency about proposed remedies for a separate enforcement action being pursued by the Illinois Attorney General. In that matter, an agreed modification to the interim agreed order was filed in December 2022, and complainant has communicated with IEPA concerning those issues. Complainant plans to provide additional comments to IEPA in response to a revised Safety Emergency Response Plan that respondent is required to file by February 23, 2023.

The parties are directed to participate in a status conference with the hearing officer at 9:30 a.m. on March 20, 2023.
