HEARING OFFICER ORDER

On January 25, 2023, the Agency emailed a request for a 90-day extension of time until April 28, 2023 to file the recommendation. On January 30, 2023, petitioner objected, stating that there is no new relief requested and the changes were made in response to the Agency's request. Petitioner stated that it would agree to a 60-day extension. The Agency responded that staff numbers are very low and there is a substantial workload. The Agency hopes to have this recommendation done well before the 90-day extension as the technical unit plans to review the petition this week. The Agency requests the extra time to avoid asking for another extension. For administrative efficiency, the request to extend the deadline to April 28, 2023 is granted.

The parties are reminded to participate in a telephone status conference at 11:00 a.m. on March 20, 2023. Petitioner will circulate a conference call-in number.
