JURISDICTION

This Administrative Citation is issued pursuant to the authority vested in the Illinois Environmental Protection Agency by Section 31.1 of the Illinois Environmental Protection Act, 415 ILCS 5/31.1 (2020).

FACTS

That Cody Smith (Respondent) is the present owner and operator of a facility located at 201
Massachusetts Street, Browning, Schuyler County, Illinois. The property is commonly known to the Illinois
Environmental Protection Agency as Browning/Smith Cody.

2. That said facility is an open dump operating without an Illinois Environmental Protection

Agency Operating Permit and is designated with Site Code No. 1690055005.

3. That Respondent has operated said facility at all times pertinent hereto.

4. That on February 14, 2023, Douglas Johnson of the Illinois Environmental Protection Agency's Springfield Regional Office inspected the above-described facility. A copy of his inspection report setting forth the results of said inspection is attached hereto and made a part hereof.

5. That on <u>March 23, 2023</u>, Illinois EPA sent this Administrative Citation via Certified Mail No. _____ 7015 0640 0005 6905 7920

VIOLATIONS

Based upon direct observations made by Douglas Johnson during the course of his February 14, 2023 inspection of the above-named facility, the Illinois Environmental Protection Agency has determined that Respondent has violated the Illinois Environmental Protection Act (hereinafter, the "Act") as follows:

- That Respondent caused or allowed the open dumping of waste in a manner resulting in litter, a violation of Section 21(p)(1) of the Act, 415 ILCS 5/21(p)(1) (2020).
- (2) That Respondent caused or allowed the open dumping of waste in a manner resulting in open burning, a violation of Section 21(p)(3) of the Act, 415 ILCS 5/21(p)(3) (2020).

CIVIL PENALTY

Pursuant to Section 42(b)(4-5) of the Act, 415 ILCS 5/42(b)(4-5) (2020), Respondent is subject to a civil penalty of One Thousand Five Hundred Dollars (\$1,500.00) for each of the violations identified above, for a total of <u>Three Thousand Dollars (\$3,000.00)</u>. If Respondent elects not to petition the Illinois Pollution Control Board, the statutory civil penalty specified above shall be due and payable no later than <u>May 22</u>, <u>2023</u>, unless otherwise provided by order of the Illinois Pollution Control Board.

If Respondent elects to contest this Administrative Citation by petitioning the Illinois Pollution Control Board in accordance with Section 31.1 of the Act, 415 ILCS 5/31.1 (2020), and if the Illinois Pollution Control Board issues a finding of violation as alleged herein, after an adjudicatory hearing, Respondent shall be assessed the associated hearing costs incurred by the Illinois Environmental Protection

Agency and the Illinois Pollution Control Board. Those hearing costs shall be assessed in addition to the One Thousand Five Hundred Dollar (\$1,500.00) statutory civil penalty for each violation.

Pursuant to Section 31.1(d)(1) of the Act, 415 ILCS 5/31.1(d)(1) (2020), if Respondent fails to petition or elects not to petition the Illinois Pollution Control Board for review of this Administrative Citation within thirty-five (35) days of the date of service, the Illinois Pollution Control Board shall adopt a final order, which shall include this Administrative Citation and findings of violation as alleged herein, and shall impose the statutory civil penalty specified above.

When payment is made, Respondent's check shall be made payable to the Illinois Environmental Protection Trust Fund and mailed to the attention of Fiscal Services, Illinois Environmental Protection Agency, 1021 North Grand Avenue East, P.O. Box 19276, Springfield, Illinois 62794-9276. Along with payment, Respondent shall complete and return the enclosed Remittance Form to ensure proper documentation of payment.

If any civil penalty and/or hearing costs are not paid within the time prescribed by order of the Illinois Pollution Control Board, interest on said penalty and/or hearing costs shall be assessed against the Respondent from the date payment is due up to and including the date that payment is received. The Office of the Illinois Attorney General may be requested to initiate proceedings against Respondent in Circuit Court to collect said penalty and/or hearing costs, plus any interest accrued.

PROCEDURE FOR CONTESTING THIS ADMINISTRATIVE CITATION

Respondent has the right to contest this Administrative Citation pursuant to and in accordance with Section 31.1 of the Act, 415 ILCS 5/31/1 (2020). If Respondent elects to contest this Administrative Citation, then Respondent shall file a Petition for Review, including a Notice of Filing, Certificate of Service, and Notice of Appearance, with the Clerk of the Illinois Pollution Control Board, State of Illinois Center, 100 West Randolph, Suite 11-500, Chicago, Illinois 60601. A copy of said Petition for Review shall be filed with the Illinois Environmental Protection Agency's Division of Legal Counsel at 1021 North Grand Avenue East, P.O. Box 19276, Springfield, Illinois 62794-9276.

Section 31.1 of the Act provides that any Petition for Review shall be filed within thirty-five (35) days of the date of service of this Administrative Citation or the Illinois Pollution Control Board shall enter a default judgment against the Respondent.

As a result of this inspection, I observed and documented apparent violations of the Illinois Environmental Protection Act (Act) and Illinois Administrative Code (Ill. Adm. Code) as they pertain to open burning and open dumping. Please refer to the Summary of Apparent Violation(s) table at the end of this report for a list of apparent violations.

Evaluation Narrative

The February 14, 2023, inspection of the Cody Smith site was conducted from 1100-1130 hours. The surrounding area is comprised of residential properties. The Schuyler County Assessment Office's parcel report indicates that the property is owned by Cody Smith. A copy of the parcel report is provided as an attachment.

I arrived on site at approximately 1100 hours and parked the state vehicle on Massachusetts Street, directly across from the subject property. Once parked, I proceeded on foot to the entrance of the site. Photograph 1 shows the view of the property from Massachusetts Street. Immediately upon entering the site, I observed a demolished on-site residence that appeared to have been recently burned (photographs 2-7). As I walked around the perimeter of the site, I observed clay bricks, concrete cinder blocks, insulation material, household waste, broken glass, scrap metal, and dimensional lumber inside the foundation of the building (photographs 8-13). I also observed burnt landscape waste that was intermingled with insulation material and other debris around the residence was razed prior to the burning of the structure along the outside of the foundation (photograph 15). After completing this inspection, I departed from the site at approximately 1130 hours.

Following the February 14, 2023, inspection, I spoke with Burl Boyd, the village president of Browning, Illinois, via phone call on March 2, 2023. According to Mr. Boyd, the residence was demolished approximately three months ago and then was set on fire the morning of January 22, 2023. Mr. Boyd also stated that no fire departments were dispatched to this fire.

After I spoke to Mr. Boyd, I searched the site address using Google Earth Pro to get an aerial view of the subject property. The imagery, which is dated November 2, 2022, appears to show the demolished onsite residence prior to being burned. I also searched the site address using Schuyler County's GIS website. The imagery from this website appears to show the on-site residence prior to demolition. The imagery date is not provided on Schuyler County's GIS website. A screenshot of the Google Earth Pro imagery and a screenshot of the Schuyler County's GIS website imagery are provided as attachments.

On March 3, 2023, I spoke with Cody Smith, who is the current owner and operator of the subject property, via phone call. I informed Mr. Smith of the complaint (#6073) that had been filed with the Illinois EPA and asked Mr. Smith to explain what activity had taken place at the subject property. Mr. Smith stated that he tore down the on-site residence approximately one year ago, using a backhoe. Prior to the demolition, Mr. Smith stated that some materials such as roofing material and lumber were taken out of the residence. Mr. Smith then stated that he burned the demolished on-site residence within the last two months of this year (2023) and that there was still snow on the ground at the time of the burn. Following the burn, Mr. Smith stated that scrap metal and other material had been taken off-site. After hearing this information, I informed Mr. Smith that the burning of a building or structure for disposal would be an apparent violation of the Illinois Environmental Protection Act.
