- That said facility is an open dump site, operating without an Illinois Environmental Protection Agency Permit, and is designated with Site Code No. 0998075005 Said facility is commonly known to the Agency as Cravatta Property.
- 3. That the Respondent has owned said facility since April 14th, 2021.
- 4. That on February 7, 2023, Lauren Grumieaux and Myranda Posada of the LaSalle County Department of Land Use, under the authority of the Illinois Environmental Protection Agency, inspected the above-described facility. A copy of the inspection reports setting forth the results of such inspections are attached hereto and made a part hereof.
- That on February 23, 2023, Lauren Grumieaux, Brian Gift, and Myranda Posada of the LaSalle County
 Department of Land Use, under the authority of the Illinois Environmental Protection Agency, inspected the
 above-described facility. A copy of the inspection reports setting forth the results of such inspections are attached
 hereto and made a part hereof.

VIOLATIONS

5. On the basis of direct observations of Lauren Grumieaux, Brian Gift, and Myranda Posada of the LaSalle County Department of Land Use, it has been determined that the Respondents have caused or allowed open dumping at the above-described facility in a manner which results in the following occurrences:

CIVIL PENALTY

- 6. Pursuant to 415 ILCS 5/42 (b) (4), formerly III. Rev. Stat. 1991, ch. 111 ½, par. 1042 (b) (4), Respondent herein is subject to a civil penalty of Fifteen Hundred Dollars (\$1500.00) for each violation specified above in Paragraph 5(b) for a total of Six Thousand (\$6000.00). Additionally, should Respondents elect to petition the Illinois Pollution Control Board under the review process described herein below, and if there is a finding of the violation alleged herein, after an adjudicatory hearing, Respondents shall be assessed the associated hearing costs incurred by the Illinois Environmental Protection Agency and the Illinois Pollution Control Board, in addition to the Fifteen Hundred Dollar (\$1500.00) statutory penalty for each finding of violation.
- 7. If you acknowledge the violations cited herein above, the civil penalty specified above shall be due and payable no later than thirty-five (35) days from the date of service hereof. If you do not petition the Illinois Pollution Control Board of review of this Administrative Citation within thirty-five (35) days of service hereof or if you elect to contest this Administrative Citation, any judgment rendered against you shall specify the due date of the statutory civil penalty and any costs assessed against you.
- 8. When payment is made, one certified check or money order for (\$3000.00) shall be made payable to the LaSalle County Treasurer and mailed to:

If any civil penalty imposed by the Illinois Pollution Control Board is not paid within the time prescribed in the order, interest from such penalty will be assessed for the period from the date payment is due until the date payment is received. If any civil penalty, by reason of acknowledgment, default or finding after the adjudicatory hearing is not paid when due, the LaSalle County State's Attorney may initiate proceedings in Circuit Court to collect said civil penalty. In addition to the previously assessed civil penalty, interest and hearing costs of the Illinois Pollution Control Board, if any, the State's Attorney's Office will seek to recover their costs of litigation.

NARRATIVE INSPECTION REPORT DOCUMENT

GENERAL REMARKS

On February 7, 2023, an open dump and open burn inspection was conducted at 916 ½ W Main St Streator, IL by Ms. Lauren Grumieaux and Ms. Myranda Posada representing the LaSalle County Land Use Department, under the delegation authority of the Illinois Environmental Protection Agency. The property is owned by Gregory Cravatta.

Weather conditions on February 7, 2023, were cloudy and 42°F wind West at 15mph

The inspection was conducted in response to a complaint alleging open dumping and burning of waste.

Ms. Grumieaux and I arrived at the site at 1:59 PM and began the inspection. We parked the vehicle on the cemetery roadway as the property is located between St, Mary's cemetery and Riverview cemetery. Part of the eastern portion of the property is also located in a floodplain. Once we arrived, we noticed a vehicle was on the property, but it appeared no one was in the vehicle at the time of the inspection. The burn pile was actively burning at the time of our arrival. I then viewed movement from inside the vehicle and informed Ms. Grumieaux of what I saw. We then made contact with the individual and Ms. Grumieaux asked if he was the owner of the property. Mr. Gregory Cravatta stated to us that he was the owner of the property. Ms. Grumieaux then asked Mr. Cravatta what he was burning and Mr. Cravatta stated it was landscape waste from the section of trees he just cleared. Ms. Grumieaux then asked Mr. Cravatta if we had permission to inspect the burn pile further. Mr. Cravatta obliged.

Looking to the southeast, I viewed the burn pile smoldering along with outdoor furniture and a pallet. (Photo #1) Making our way to the northern side of the property, we viewed more pallets, tires, gutters, tarping, and weathered construction materials lining the hillside. (Photo #2) Ms. Grumieaux asked if he had any intentions to burn the materials lining the area. Mr. Cravatta stated that those were materials that he had pulled out of the burn pile. Facing southeast, we viewed pieces of carpeting, siding, and landscape waste in the burn pile. (Photo #3) We then made our way back to the northern portion of the property, where we viewed a second burn pile. The second pile contained demolition and construction debris. (Photo #4) Ms. Grumieaux asked Mr. Cravatta if he was plowing the demolition and construction debris off the hillside and into the floodplain area. Mr. Cravatta stated that he doesn't have the means to push the waste over the hillside. Ms. Grumieaux pointed out that a plow was attached to the front of his truck, and the markings on the ground would indicate otherwise.

Continuing on, we viewed a pile of shingles near the edge of the hillside. I also viewed gutters and installations that appeared to have been recently dumped. (Photo #5) More construction materials were viewed lining the area. Some of the materials included a kitchen sink, garbage bins, blinds, and

metal racking. (Photo #6)

Next, we inspected the hillside. More insulation and demolition debris were viewed spilling over into the hillside where the floodplain area is. I also viewed a water heater, more shingles, charred material, and concrete blocks spilling into the floodplain area as well. (Photo #7 & Photo #8) I inspected the second burn pile where I documented charred metal, springs, plastics, plumbing materials, siding, and more household waste. (Photo #9)

We then made our way further to the eastern side of the property, where a large pile of clean construction demolition debris (CCDD) was located. While inspecting the pile more thoroughly we documented rebar in the CCDD and litter comingled within the area. I also viewed some landscape waste and a toilet in the area as well. (Photo #10 & Photo #11) Ms. Grumieaux and I then heard a small explosion come from the active burn pile. Due to the explosion and the size of the fire, we called our director of the Land Use Department, Mr. Brian Gift. Ms. Grumieaux and I were concerned that the fire may be too big for Mr. Carvatta to put out on his own, Mr. Gift agreed that that Mr. Cravatta should contact the Streator Fire Department to put out the fire. Once off the phone, we made our way to Mr. Cravatta to inform him that the fire would need to be extinguished, and due to the explosion and size of the fire, that he would need to contact the fire department. Mr. Carvatta was hesitant at first and informed us that the fire department would be upset; as they have been out to his property multiple times. Mr. Carvatta then agreed to call the fire department.

Once the fire department arrived, we introduced ourselves and spoke to Captain David Kupec and Firemen Eric Hoffmeyer. Captain Kupec asked if we received the complaint for the active fire today. We informed him that we received the complaint the day prior and Mr. Cravatta just happened to be burning at the time of our arrival. Ms. Grumieaux then informed Captain Kupec and Mr. Hoffmeyer that due to the explosion, size of fire, and wind conditions; we felt the best option was for the fire to be extinguished. After our discussion, the Firemen then began putting the fire out. (Photo #12) While watching the Firefighters tend to the burn, the Chief of the Streator Fire Department arrived at the site. Chief Gary Bird made contact with us and after a brief introduction, we informed him of the situation on-site.

After the firemen extinguished the fire, we inspected the area more thoroughly. Facing southeast, I viewed a door frame that was not visible when the fire was burning. (Photo #13) Mr. Hoffmeyer was able to comb through the ash and charred materials. While sifting through the ash, Mr. Hoffmeyer discovered aerosol cans and stated that the explosion was likely due to the cans. While he and Captain Kupec continued to move the waste around, Mr. Hoffmeyer found charred metal car parts in the pile. (Photo #14) After documenting the charred materials, Ms. Grumieaux addressed the findings with Mr. Cravatta. She explained that moving forward, Mr. Cravatta would need to cease all open dumping and open burning. She also explained that the only material that he would be able to burn on site is landscape waste generated from the property. Mr. Cravatta stated to us that other people dump on his property, and he was not aware that it had gotten out of hand. Ms. Grumieaux informed him that all the burnt remains would need to be removed and taken to a permitted facility. She also addressed the waste strewn along the hillside and in the floodplain. She stated that the area would need to be excavated and all waste removed before we can consider closing the case with the IEPA. Mr. Cravatta left the area to make a phone call. Once Mr. Cravatta returned, he stated that he spoke to the person who is responsible for the open dumping. He stated that the property would be

clean and the waste removed by Friday. After documenting our findings, Ms. Grumieaux and I thanked Mr. Cravatta and the Streator Fire Department for their help. We concluded the inspection at 3:18 PM.





NARRATIVE INSPECTION REPORT DOCUMENT

GENERAL REMARKS

On February 23, 2023, an open dump and open burn re-inspection was conducted at 916 ½ W Main St Streator, IL by Ms. Lauren Grumieaux, Mr. Brian Gift, and Ms. Myranda Posada representing the LaSalle County Land Use Department, under the delegation authority of the Illinois Environmental Protection Agency. The property is owned by Gregory Cravatta.

Weather conditions on February 23, 2023, were cloudy and 37°F wind West at 23mph

The inspection was conducted in response to continued complaints alleging open dumping on the property.

Ms. Posada, Mr. Gift, and I arrived at the site at 9:36 AM and were met by the Streator Fire Department, City Engineer, Mr. Jeremy Palm, and the City Code Enforcement officer, Mr. Joe Scarbeary. After a brief introduction, we made our way to the northern portion of the property, to view the site. The burn pile that was located near the center of the parcel had been removed since the last inspection. A small pile of tree brush was all that was left in the area. (Photo#1) Making our way to the hillside, we viewed the lower land, near the floodplain. The lower portion of the property contained more demolition waste, shingles, and construction materials than it had during the previous inspection. It appeared that the waste from the burn pile had been pushed/dumped over the hillside, as a means to clean the area. (Photo#2) Due to the increase in the amount of waste, Ms. Posada and I made our way to the lower portion of the property, to get a better view. Looking to the southeast, we viewed construction materials, demolition waste, furniture, pallets, plastics, and other household items. (Photos#3- #5) Miscellaneous waste tires were also viewed at the foot of the hillside. (Photo#6) While documenting the area, we noted that a couch and other large items were buried under the rock and demolition debris. (Photo#7) Turning to the north, we viewed more waste tires strewn throughout the wooded lot. (Photo#8) Mr. Gift noted that it appeared that any of the runoff from the waste on the hillside would make its way to the nearby Vermillion River, which is less than 100' from the waste.

After documenting our findings, we concluded the inspection at 10:00 AM.


