Corporation Inc., Thomas Maxwell, and James McIlvain, a Necessary Party</u> (Water, UST – Enforcement) – Upon receiving a stipulation, proposed settlement, and request for relief from the hearing requirement in this enforcement action concerning a DeWitt County gas station, the Board directed the Clerk to provide the required newspaper notice.	4-0 roll call vote
<u>PCB 22-40</u>	<u>People of the State of Illinois v. MDDS Real Estate, Inc., d/b/a Citgo Petroleum</u> (Air – Enforcement) – Upon receiving a stipulation, proposed settlement, and request for relief from the hearing requirement in this enforcement action concerning a Cook County gas station, the Board directed the Clerk to provide the required newspaper notice.	4-0 roll call vote
<u>PCB 23-8</u>	<u>People of the State of Illinois v. Downtown Oil Company, LLC</u> (Air – Enforcement) – The Board granted the People’s motion for voluntarily dismissal, dismissed the case, and closed the docket.	4-0 roll call vote
<u>PCB 23-35</u>	<u>People of the State of Illinois v. 3803 Roosevelt LLC, d/b/a BP</u> (Air – Enforcement) – In this enforcement action concerning a Cook County gas station, the Board granted relief from the hearing requirement of Section 31(c)(1) of the Environmental Protection Act (415 ILCS 5/31(c)(1) (2020)), accepted the parties’ stipulation and proposed settlement, and ordered BP to pay a civil penalty of \$5,000 and to cease and desist from further violations.	4-0 roll call vote
<u>PCB 23-36</u>	<u>People of the State of Illinois v. R & D # 1 Inc., d/b/a BP Gas Station</u> (Air – Enforcement) – Upon receiving a stipulation, proposed settlement, and request for relief from the hearing requirement in this enforcement action concerning a Cook County gas station, the Board directed the Clerk to provide the required newspaper notice.	4-0 roll call vote

<u>PCB 23-89</u>	<u>Bunge North America, Inc. v. Illinois Environmental Protection Agency</u> (Permit Appeal – Air) – The Board accepted for hearing this permit appeal involving Bunge North America’s soybean processing facility in Alexander County. The Board reserved ruling on Bunge North America’s motion to stay the contested permit conditions.	4-0 roll call vote


