# PROTECT WEST CHICAGO'S MOTION FOR LEAVE TO FILE ITS RESPONSE TO MOTION TO STRIKE NO LATER THAN MAY 12, 2023

NOW COMES the Petitioner, Protect West Chicago, ("PWC"), by and through its attorney, Meza Law, and hereby files its Motion for Leave to File Its Response to Motion to Strike no Later than May 12, 2023. In support hereof, PWC states as follows:

- 1) On March 28, 2023, PWC filed its initial Petition pursuant to Section 40.1 of the Illinois Environmental Protection Act, 415 ILCS 5/401.1 ("Act"), in accordance with Sections 107.200 through 107.208 of the PCB procedural rules, 35 Ill Admin. Code §§ 107.200-208.
- 2) On April 6, 2023, the Illinois Pollution Control Board issued an Order accepting PWC's petition for hearing.

3) On April 14, 2023, Lakeshore Recycling Systems, LLC filed a Motion to Strike the

Illinois Pollution Control Board's April 6, 2023 Order.

4) Pursuant to the 35 Ill Admin Code §101.400(d) a party may file a response to a

Motion within 14 days after service of a motion on a party. Thus, the Response of PWC is currently

due on April 28, 2023.

5) Pursuant to 35 Ill Admin Code §101.400(d), a party may request additional time to

respond by filing a motion for an extension of time prior to the time the response period expires.

As of this writing, the response period has not expired.

6) PWC seeks an additional fourteen days or until May 12, 2023 to file its response to

the Motion to Strike as undersigned counsel will be on personal leave from April 26 through April

30, 2023.

7) WHEREFORE, PWC respectfully requests the PCB to enter an Order allowing

PWC to file its Response to the Motion to Strike no later than May 12, 2023 and provide such

other and further relief as the Board deems appropriate.
