
HEARING OFFICER ORDER

On May 25, 2023, all parties participated in a telephonic status conference. Midwest Generation, LLC., (16-19) (MWG) Eight Motion to Extend Stay of Proceedings (Mot.), filed May 24, 2023, was addressed. MWG reported that it has forwarded draft permits to the Illinois Environmental Protection Agency (Agency) for review. The Agency has reviewed them and added comments. The Agency is now reviewing MWG's resubmittal. MWG's motion is granted to September 1, 2023.

INEOS Joliet, LLC. (16-24) (INEOS) reported that it submitted an updated draft demonstration document to the IEPA that was under review. The Agency has no comments to the draft. INEOS anticipates filing the petition within 30-days.

The parties or their legal representatives in PCB 16-19 are directed to participate in a telephonic status conference with the hearing officer on June 27, 2023, at 10:00 a.m. The parties or their legal representatives in PCB 16-24 are directed to participate in a telephonic status conference with the hearing officer on June 27, 2023, at 10:15 a.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


