On June 6, 2023, the petitioner filed a motion for extension of time to file motion for reconsideration and/or clarification of the interim order and opinion and request for expedited decision. (Mot.) Petitioner states that "[t]his extension is for good cause because MWG is investigating whether there are more accurate and scientific methods to analyze the soil in the berms and the poz-o-pac to address the concerns Illinois EPA related to the material in the berms and poz-o-pac." Mot. at 1-2. Petitioner states that the Illinois EPA has no position on the requested extension. *Id.* at 2.

Petitioner's motion for extension to July 13, 2023, is granted.

It is noted that in paragraph 1 of the motion, petitioner states that the above-captioned adjusted standard petition is in "the liability phase of this lawsuit." Mot. at 1. That statement is incorrect and misstates the procedural posture of this matter. Perhaps petitioner used the PCB 13-15 template to draft this motion in AS 21-1.
