### JURISDICTION

This Administrative Citation is issued pursuant to the authority vested in the Illinois Environmental Protection Agency by Section 31.1 of the Illinois Environmental Protection Act, 415 ILCS 5/31.1 (2022).

## FACTS

1. That Grant Gutierrez d/b/a Grant Gutierrez Junk Car Removal is the present owner/operator of a property located at 2908 265<sup>th</sup> St N, Rock Island, Rock Island County, Illinois. The property is commonly known to the Illinois Environmental Protection Agency as Rock Island/Gutierrez Grant.

2. That said facility is an open dump operating without an Illinois Environmental Protection Agency Operating Permit and is designated with Site Code No. 1618170008.

3. That Respondent has operated said facility at all times pertinent hereto.

4. That on May 3, 2023, Jason Thorp of the Illinois Environmental Protection Agency's Peoria Regional Office inspected the above-described facility. A copy of his inspection report setting forth the results of said inspection is attached hereto and made a part hereof.

5. That on <u>June 12, 2023</u>, Illinois EPA sent this Administrative Citation via Certified Mail No. <u>7012 0470 0001 2969 5056</u> to Grant Gutierrez d/b/a Grant Gutierrez Junk Car Removal.

#### VIOLATIONS

Based upon direct observations made by Jason Thorp during the course of his March 23, 2023 inspection of the above-named facility, the Illinois Environmental Protection Agency has determined that Respondent has violated the Illinois Environmental Protection Act (hereinafter, the "Act") as follows:

- (1) That Respondent caused or allowed the open dumping of waste in a manner resulting in litter, a violation of Section 21(p)(1) of the Act, 415 ILCS 5/21(p)(1) (2022).
- (2) That Respondent caused or allowed the open dumping of waste in a manner resulting in open burning, a violation of Section 21(p)(3) of the Act, 415 ILCS 5/21(p)(3) (2022).
- (3) That Respondent caused or allowed the open dumping of waste in a manner resulting in deposition of general construction or demolition debris or clean construction or demolition debris, a violation of Section 21(p)(7) of the Act, 415 ILCS 5/21(p)(7) (2022).

#### CIVIL PENALTY

Pursuant to Section 42(b)(4-5) of the Act, 415 ILCS 5/42(b)(4-5) (2022), Respondent is subject to civil penalties of One Thousand Five Hundred Dollars (\$1,500.00) for each of the violations identified above, for a total of <u>Four Thousand Five Hundred Dollars (\$4,500.00)</u>. If Respondent elects not to petition the Illinois Pollution Control Board, the statutory civil penalties specified above shall be due and payable no later than <u>August 7, 2023</u>, unless otherwise provided by order of the Illinois Pollution Control Board.

If Respondent elects to contest this Administrative Citation by petitioning the Illinois Pollution Control Board in accordance with Section 31.1 of the Act, 415 ILCS 5/31.1 (2022), and if the Illinois Pollution Control Board issues a finding of violation as alleged herein, after an adjudicatory hearing, Respondent shall be assessed the associated hearing costs incurred by the Illinois Environmental Protection Agency and the Illinois Pollution Control Board. Those hearing costs shall be assessed in addition to the One Thousand Five Hundred Dollar (\$1,500.00) statutory civil penalty for each violation.

Pursuant to Section 31.1(d)(1) of the Act, 415 ILCS 5/31.1(d)(1) (2022), if Respondent fails to petition or elect not to petition the Illinois Pollution Control Board for review of this Administrative Citation within thirty-five (35) days of the date of service, the Illinois Pollution Control Board shall adopt a final order, which shall include this Administrative Citation and findings of violation as alleged herein, and shall impose the statutory civil penalty specified above.

When payment is made, Respondent's check shall be made payable to the Illinois Environmental Protection Trust Fund and mailed to the attention of Fiscal Services, Illinois Environmental Protection Agency, 1021 North Grand Avenue East, P.O. Box 19276, Springfield,

Illinois 62794-9276. Along with payment, Respondent shall complete and return the enclosed Remittance Form to ensure proper documentation of payment.

If any civil penalty and/or hearing costs are not paid within the time prescribed by order of the Illinois Pollution Control Board, interest on said penalty and/or hearing costs shall be assessed against the Respondent from the date payment is due up to and including the date that payment is received. The Office of the Illinois Attorney General may be requested to initiate proceedings against Respondent in Circuit Court to collect said penalty and/or hearing costs, plus any interest accrued.

### PROCEDURE FOR CONTESTING THIS ADMINISTRATIVE CITATION

Respondent has the right to contest this Administrative Citation pursuant to and in accordance with Section 31.1 of the Act, 415 ILCS 5/31/1 (2022). If Respondent elects to contest this Administrative Citation, then Respondent shall file a Petition for Review, including a Notice of Filing, Certificate of Service, and Notice of Appearance, with the Clerk of the Illinois Pollution Control Board, State of Illinois Center, 100 West Randolph, Suite 11-500, Chicago, Illinois 60601. A copy of said Petition for Review shall be filed with the Illinois Environmental Protection Agency's Division of Legal Counsel at 1021 North Grand Avenue East, P.O. Box 19276, Springfield, Illinois 62794-9276.

Section 31.1 of the Act provides that any Petition for Review shall be filed within thirty-five (35) days of the date of service of this Administrative Citation or the Illinois Pollution Control Board shall enter a default judgment against the Respondent.

## **Executive Summary**

On May 3, 2023, I (Jason Thorp, BOL/FOS - Peoria) conducted an unannounced Resource Conservation and Recovery Act (RCRA) follow-up inspection from 12:24 - 12:46 hours at a salvage yard ("facility") owned by Grant Gutierrez and operated by Grant Gutierrez d/b/a Grant Gutierrez Junk Car Removal located at 2908 265<sup>th</sup> Street N in rural Hillsdale, Rock Island County, Illinois (41.55082<sup>o</sup>, -90.25606<sup>o</sup>). The purpose of the follow-up inspection was to determine if the 40 yd<sup>3</sup> of solid waste observed during the April 19, 2023 RCRA Citizen Complaint Investigation (CCI) had been disposed by open burning on April 28, 2023, as reported by the complainant in an e-mail dated May 1, 2023.

The reported open burning was substantiated as I observed new apparent violations for open dumped solid waste and evidence of open burned solid waste.

## **Evaluation Narrative**

### Background

On April 19, 2023, I conducted an unannounced RCRA CCI at the facility in response to complaint allegations listed in Complaint No. 6248 that Mr. Gutierrez was improperly disposing of vehicles fluids generated from vehicle scrapping operations. Mr. Gutierrez was not present on-site, but was notified by telephone of my intentions to conduct a RCRA CCI. The complaint allegations were substantiated as I observed apparent violations of Sections 12(a), 12(d), 21(a), 21(d)(1), 21(e), 21(k), 21(p)(1), 21(p)(7), 55(a)(1), 55(a)(4), 55(a)(5), 55(c), 55(d)(1), and 55(e) of the Environmental Protection Act and Sections 739.122(d), 848.202(a)(1), 848.202(a)(6), 848.305(c), 848.307, 848.607(c), and 848.609 of the Title 35 Illinois Administrative Code during the RCRA CCI for operating an unregistered tire storage site; failure to pay the required annual fee; failure to meet used tire fire break requirements; failure to use tire tracking receipts; failure to clean-up used oil releases; and open dumped solid waste comprised of vehicles parts, furniture, and general construction or demolition debris.

On April 21, 2023, I telephoned Mr. Gutierrez to inform him of the RCRA CCI findings and corrective actions necessary to return the facility to compliance. Mr. Gutierrez was instructed not to dispose any of the open dumped solid waste present on-site by means of open burning, except for landscape waste generated on-site if local ordinances allowed such activity.

On May 1, 2023, I received an e-mail from the complainant indicating that a large fire occurred at the facility on Friday, April 28, 2023.

#### Inspection

The follow-up inspection commenced at 12:24 hours. I collected digital photographs to document observations made during the follow-up inspection. The digital photograph locations and GPS coordinates for the facility entrance have been plotted on the Illinois EPA Site Map included with this inspection report. Digital photograph 1 depicts an overview of the facility as observed from the entrance located along 265th Street N.

Mr. Gutierrez was present on-site and participated in the follow-up inspection. I observed continuing apparent violations and new apparent violations for open dumped solid waste and evidence of open burned solid waste. Digital photograph 2, 3, 5, and 6 depict the area where open dumped solid waste and evidence of open burned solid waste was observed during the follow-up inspection. Digital photograph 4 depicts a closer view of the open dumped solid waste and evidence of open burned solid waste and evidence of open burned solid waste. Digital photograph 7, included in this inspection report for reference purposes, was collected during the RCRA CCI conducted on April 19, 2023 and depicts an estimated 40 yd<sup>3</sup> of open dumped solid waste comprised of furniture and general construction or demolition debris (dimensional lumber, plywood, wood fencing, and wood spools) present on-site prior to being open burned by Grant Gutierrez on Friday, April 28, 2023.

I reminded Mr. Gutierrez of our April 21, 2023, telephone conversation when I provided instructions not to burn any of the open dumped solid waste present on-site. Mr. Gutierrez responded by saying that he thought burning the solid waste would be alright since the waste was already in a pile to be burned. I again, informed Mr. Gutierrez of the corrective actions necessary to return the facility to compliance and to cease open burning of solid waste present on-site.

The follow-up inspection concluded at 12:46 hours.



Affiant, Jason Thorp, being first duly sworn, voluntarily deposes and states as follows:

1. Affiant is a field inspector employed by the Bureau of Land of the Illinois Environmental Protection Agency and has been so employed at all times pertinent hereto.

2. On May 3, 2023, between 12:24 and 12:46, Affiant conducted an inspection of the site in Rock Island County, Illinois, known as Gutierrez Grant, located at 2908 265th Street N, Hillsdale, Illinois 61257, and designated Bureau of Land Site # 1618170008.

3. Affiant inspected said site by an on-site inspection, which included walking the site.

4.
