ENVIRONMENTAL GROUPS' SECOND RENEWED REQUEST AND CITY OF WAUKEGAN'S REQUEST FOR PUBLIC HEARING

Pursuant to 35 Ill. Adm. Code 104.420(a), Clean Power Lake County, Earthjustice, Prairie Rivers Network, and Sierra Club (collectively, "Environmental Groups"), together with the City of Waukegan, request a public hearing in the above-referenced matter on Midwest Generation, LLC's Second Amended Petition for an Adjusted Standard and Finding of Inapplicability for Waukegan Station, filed on July 28, 2023. Midwest Generation published notice of its Second Amended Petition on August 4, 2023,¹ making this request timely under 35 Ill. Adm. Code 104.420(a).

In support of our request, we incorporate as if fully set out herein, Environmental Groups' original Request for Public Hearing in this matter, filed on June 7, 2021, which describes the reasons a public hearing is crucial in this matter.² We also renew Environmental Groups' request, as set forth in their Renewed Request for Public Hearing filed on October 18, 2021, that the hearing be held in a hybrid manner similar to the public hearings held in R2020-19 because the need to travel to either Chicago or Springfield could, for some staff or members of our organizations, limit the ability to participate in the hearing. If a full hybrid hearing is not possible, we renew our request that the portion of the hearing dedicated to oral public comment be conducted in a hybrid manner.

Finally, we underscore the importance of resolving this matter expeditiously, as reflected in the multiple comments that Environmental Groups and the City of Waukegan have filed in this docket describing the urgent need to address coal ash pollution in Waukegan, an area of environmental justice concern that must be prioritized under the Coal Ash Pollution Prevention Act.³
