PROTECT WEST CHICAGO'S MOTION FOR ORDER REQUIRING THE CITY OF WEST CHICAGO TO POST NOTICE OF THE SEPTEMBER 28, 2023 <u>HEARING ON ITS WEBSITE AND RELATED RELIEF</u>

NOW COMES the Petitioner, Protect West Chicago, ("PWC"), by and through its attorneys, Meza Law, and submits its Motion For Order Requiring the City of West Chicago to Post Notice of the September 28, 2023 Illinois Pollution Control Board Hearing on the City of West Chicago's Website, as well as Notice of the Opportunity for members of the public to provide public comment at said hearing, and in support thereof, PWC states as follows:

1) On March 28, 2023, PWC initiated proceedings before the Illinois Pollution Control Board ("IPCB") seeking review of the City of West Chicago's decision granting site location approval to Lakeshore Recycling Systems, LLC ("Lakeshore" or "Applicant") for the

proposed West DuPage Recycling and Transfer Station, located at 1655 Powis Road, West Chicago, IL ("Application").

2) On April 14, 2023, PWC filed its Amended Petition for Review before the IPCB, which alleged, among other things, that the entire local siting review process demonstrated an inherent bias in favor of Lakeshore that occurred both prior to the filing of the Application and thereafter.

3) Specifically, in its April 14, 2023 Amended Petition, PWC alleged that the inherent bias of the City of West Chicago was exhibited through, among other things, such things as the City's:

- a. failure to provide "reasonable access or availability of hearing proceedings in Spanish,"
 as well as the "scheduling of the actual hearing dates;"
- b. West Chicago officials' efforts to conceal information which related directly to criticisms leveled by the City's own consultant; as well as,
- c. West Chicago officials' decision to deliberate "in a private closed session," in order to approve Lakeshore's Application and Ordinance 23-O-006.

And, as also set forth in its Amended Petition, the actions of the City of West Chicago reveal and confirm that "a disinterested observer might conclude that the local siting authority adjudged both the facts and the law before hearing the case."

4) On July 12, 2023, PWC filed with the IPCB its Notice of Request to the Illinois Attorney General's Public Access Counselor for a Determination of Open Meetings Act violations. PWC's request to the AG's Public Access Counselor was prompted by the City's perceived efforts, in PWC's opinion, to conceal from the public what should have been open deliberations during the City of West Chicago's review of Lakeshore's Application, which took place in a closed session.

5) As of this writing, PWC has not received any response from the Public Access Counselor regarding its Request for a Determination.

6) On August 7, 2023, at a regularly scheduled status hearing in this matter, the parties agreed to set the public hearing before the Illinois Pollution Control Board for September 28, 2023 at West Chicago's City Hall. Then, three days later, and as set forth in Hearing Officer Bradley Halloran's August 10, 2023 Order, the September 28, 2023 date was memorialized as follows:

On August 7, 2023, all parties participated in a telephonic status conference. It was agreed that a hearing will be scheduled for September 28, 2023. The location will be in the Council Room at the City of West Chicago Village Hall. Notice will be issued in a timely fashion. See Exhibit 1.

On August 22, 2023, the IPCB then entered a "Notice of Hearing" in this matter, setting September 28, 2023 as the Hearing date and providing the stated time and location. <u>See</u>
 <u>Exhibit 2</u>.

8) On August 28, 2023, the Illinois Pollution Control Board filed its Certificate of Publication in which it informed the parties that it had provided public notice of the September 28, 2023 Hearing in the Daily Herald, a newspaper that has been in "general circulation daily throughout DuPage County, continuously for more than 50 weeks prior to the first Publication of the attached notice, and a newspaper as defined by 715 ILCS 5/5." <u>See Exhibit 3.</u>

9) However, despite having been on notice since at least August 7, 2023 that there will be a public hearing on September 28, 2023 at the City of West Chicago's City Council Room, a review of the City of West Chicago's website does not include any information about the scheduled September 28, 2023 Illinois Pollution Control Board Hearing.

10) Specifically, a September 11, 2023 review of West Chicago's website and in particular their "splash page" (introduction page) reveals that although West Chicago has informed its citizens that registration was open for the "Healthy West Chicago 5K on September 23"; that a

"West Chicago Man" was charged in a fatal traffic accident; and that the City has declared September 2023 as "National Service Dog Month," there is absolutely no information relating to the scheduled September 28, 2023 Hearing to be held in the City Council Room. In fact, a review of the West Chicago events calendar for September 2023 (depicted below and found at: https://westchicago.org/events/) also provides no information relating to the September 28, 2023 public hearing.

11) While PWC in no way seeks to diminish the significance of the City of West Chicago's upcoming 5K event or the recognition of September as "National Dog Service Month," PWC nonetheless believes that the scheduled hearing on September 28, 2023, related to its decision to approve Lakeshore's Application for a waste transfer station is also deserving of citizen notification via West Chicago's website "splash page" and website calendar of events.

12) On September 11, 2023, counsel for PWC asked counsel for West Chicago whether

they would be willing to post the following Notice (in English and Spanish) on the City of West

Chicago's "splash page":

To All West Chicago Residents and Interested Parties:

On September 28, 2023, at 9:00 am, at the City of West Chicago's City Council Room, 475 Main Street, West Chicago, Illinois:

The Illinois Pollution Control Board will hold a Public Hearing in the matter of <u>Protect</u> <u>West Chicago v. West Chicago, the West Chicago City Council, and Lakeshore</u> <u>Recycling Systems, LLC and People Opposing DuPage Environmental Racism v.</u> <u>City of West Chicago and Lakeshore Recycling Systems.</u>

This hearing relates to the City of West Chicago's decision to approve Lakeshore Recycling Systems. LLC's application to operate a Pollution Control Facility (Waste Transfer Station) at 1655 Powis Road, West Chicago, IL. All persons will be offered an opportunity to provide comments. <u>See Exhibit 4</u>.

13) In response to the request from counsel for PWC to place the Notice of the City of

West Chicago's website, Mr. Dennis Walsh denied the request and stated as follows:

We are going to deny your request because under the regulations notice of the hearing is done by the Clerk of the Board in a very specific way; interested persons may contact the Clerk's Office or the hearing officer for information about the hearing and the hearing officer is the one who makes the determination as to what limited participation rights nonparties will have at the hearing. Members of the public are allowed to make comments only as the hearing officer allows. **Id.**

14) In light of the issues in this matter, as well as the City of West Chicago's response

to PWC's reasonable request to provide notice of the hearing on West Chicago's website, to the

extent that the Illinois Pollution Control Board will allow members of the public to provide comment and/or statements on September 28, 2023, an Order requiring West Chicago to place notice of the September 28, 2023 hearing and notice of the opportunity to provide comment (in English and Spanish) should be entered.

WHEREFORE, PWC moves for an Order requiring the City of West Chicago to post on its website "splash page," as well as on its calendar of events, notice of the scheduled September 28, 2023 Public Hearing before the Illinois Pollution Control Board, as well as information relating to the public's ability to provide comment and/or statements at said hearing and to order any such other and further relief as the Board deems appropriate.


