

This notice is published pursuant to 415 ILCS 5/28.1 and 35 III. Adm. Code 104.408 to inform the public of the submittal by Rain CII Carbon LLC ("Rain Carbon") of a Petition for an Adjusted Standard with the Illinois Pollution. Control Board (the Braard) Pollution Control Board (the "Board") pursuant to 35 III. Adm. Code 104.402 on August 14, 2023, Rain Carbon's petition, which has been assigned to Docket No. AS 2024-005 (crutiestic ac administration) assigned to Docket No. AS 2024-005, requests an adjusted standard from 35 III. Adm. Code 201149, 212.123, 212.322, and 216.301 for Rain Carbon's coke calcining facility located at 12187 East 950th Ave., Robinson, Crawford County, Illinois (the 'Facility').
