The Attorney General has brought a case against Nasser Yafai, Quick Gas & Mini Mart, Inc., CYPR Harvey, Inc. d/b/a Quick Gas & Mini Mart, Inc., and Harvey Real Estate, Inc. for violating State pollution control rules. On December 1, 2023, the parties filed a stipulation and proposal for settlement as to Nasser Yafai and Quick Gas & Mini Mart, Inc., only. The parties agree that a hearing is unnecessary, and in accordance with State law, have requested that the settlement be adopted without holding a public hearing. Any person who would like to comment on, or demand a public hearing on, the stipulation and proposal for settlement may do so by filing a written comment or hearing demand with the Illinois Pollution Control Board within 21 days after the publication of this notice.
