The Attorney General has brought a case against Techo-Bloc Midwest Corp. for violating State pollution control rules. On November 17, 2023, the parties filed a stipulation and proposal for settlement. Any person who would like to comment on, or demand a public hearing on, the stipulation and proposal for settlement may do so by filing a written comment or hearing demand with the Illinois Pollution Control Board within 21 days after the publication of this notice. The written comment or hearing demand must refer to People of the State of Illinois v. Techo-Bloc Midwest Corp., PCB 24-35, and must be filed with the Clerk of the Illinois Pollution Control Board, 60 East Van Buren, Suite 630, Chicago, Illinois 60605.
