
**HEARING OFFICER ORDER**

On January 25, 2024, all parties participated in a telephonic status conference with the hearing officer. It was noted that the Agency filed its Recommendation on September 27, 2023. It is also noted that the Illinois Department of Natural Resources counsel (IDNR), during the conference call that an attachment to the Recommendation from the IDNR approval of the Agency's submission is dated April 15, 2022, and the approval expires in 2 years, or April 15, 2024. The Agency's counsel stated that it will confer with its technical staff for a possible re-initiation of the submittal if need be. Counsel is directed to advise the petitioner and the Board of its results.

The petitioner stated that it is awaiting any further questions/directives from the Board, whether to proceed to hearing or make its ruling.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on March 21, 2024, at 9:45 a.m. The telephonic status conference must be initiated by the petitioner with the petitioner providing the call-in number. Each party is responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the case.
