Something, they have already done for me. And Dan's threatening email eluded to using lawyers to intimidate me away from pursuing my constitutional rights. Given the issues at hand and changes to IL law which involve criminal charges and the need to twice in the legislation inform local police they are to enforce relevant pollution laws.
