MOTION TO EXTEND TIME FOR FILING RECORD

Now Comes Respondent, ILLINOIS ENVIRONMENTAL PROTECTION AGENCY, through its counsel, the Illinois Attorney General's Office, and hereby requests that the Board allow additional time, until March 14, 2024, for filing the administrative record in this matter. In support of its request, Respondent states, as follows:

- 1. After an agreed 90 day extension, Complainant filed the instant permit appeal with the Board on January 30, 2024. In accordance with 35 Ill. Adm. Code 105.116, the record of Illinois EPA's permit decision was due to be filed on or before February 29, 2024.
- 2. Despite its best efforts, Respondent has been unable to organize, categorize, and number the entire permit record by February 29, 2024. Respondent believes that it will be able to provide a complete record within 14 additional days, or by March 14, 2024.
- 3. The undersigned has contacted counsel for Petitioner, who advised that he does not object to Respondent's request.
- 4. In accordance with 35 Ill. Adm. Code 105,116, this Motion is timely filed before the date on which the record was originally due.
