Im not filing a response because there is no need to respond when the case is entirely based on pictures and the respondent is restricting access to regulatory documents. You have, for all the cases involved, more than enough to proceed, but to take action would mean to admit the board and EPAs total failure.

As this is yet another example where the board refuses to enforce any constraints on violators and their scumbag lawyers, but freely directs and orders around. Granting more time for violations to occur and records to be altered.

I am going to be elevating all of my formal complaints to the FBI and to include the IL EPA and the IL Pollution Control board. As you have both stood by as me any my family were harassed and permit holders threatened to call the police on me for engaging in actions protected by the constitution.

My dad is a devout Catholic who attended all catholic schools through grad school before working at USEPA. The one time he was in a court room he was appalled by the unprofessional behavior of the attorneys who acted like they were the only ones in the room. And their schedules were the only ones that mattered.

You have a picture of Lexington homes washing out a cement truck into a storm drain next to a wetland. In the years since, how many times have you ordered me, and how many times have you ordered the law be followed.

Listen careful, you have all the information you need to investigate and make arrests. Two years later, you are still ordering me around even when criminals called the police and made false reports when I held them accountable.

Because you are a bunch of soulless scumbag lawyers who sit in the middle of the most corrupt city in the country. And the second you enforce the rules, it becomes clear how you have not been for decades.

Due to the severe nature of this case, the attempts by lexington to make unauthorized secret recordings, the threats to me, attempts at manipulating the police, need for police protection of constitutional rights, the fraud, the damage to protected wetlands and that an attorney from the IL Attorney Generals office witnessed me investigate and uncover the fraud in three minutes of real time. This matter, which includes the failures of the board, and head scumbag lawyer Brad Haloran, who continues to delay cases for years only to make up reasons to order me to do things I cannot afford which he knows.

This case and all materials, with a new narrative complaint against The Board will be submitted to the FBI tomorrow April 5, 2024.

As part of this, I will be seeking the dissolution of the board and an investigation into the handling of cases by Brad. And reaching back out my contact at the UN who sits on the board managing the current river restoration projects.

Back The Blue 901: The same way these people in IL allowed criminals to make false reports against me when I hold them accountable. I just left my local post office. The station manager threatened to call the police on me for reporting our incoming mail being stolen, outgoing mail not taken. That too was just elevated to a higher investigative team. See pics and make sure Memphis PD are aware of attempts to falsely report me for making a disturbance as I follow up on federal crimes. Her case was elevated by USPS to consumer affairs and the postal inspection service.
