

HEARING OFFICER ORDER

On May 23, 2024, all parties appeared for a telephonic status conference. Counsel for petitioner reported that the matter is proceeding according to the Ninth Status Report filed April 4, 2024. A related petition was filed and was accepted by the Board. INEOS Joliet v. Illinois Environmental Protection Agency PCB 23-135 (August 17, 2023). It is noted that when PCB 23-135 is resolved, this PCB 16-24 matter will be resolved.

IT IS SO ORDERED.




