**HEARING OFFICER ORDER**

This case is part of a group of alternative source demonstration petitions. The parties have decided to proceed with summary judgment motions for Illinois Power Generating Company v. IEPA, PCB 24-43, the outcome of which will determine how the parties proceed with the remaining dockets (PCB 24-45, PCB 24-48, PCB 24-53, PCB 24-55, PCB 24-56).

On May 2, 2024, the Board granted the parties' motion to stay the proceedings until July 31, 2024 to ensure that a summary judgment schedule would be set for PCB 24-43. The Board further noted that additional stays may be requested from the hearing officer.

On June 17, 2024, the parties agreed to a summary judgment schedule for PCB 24-43 due to be completed no later than November 15, 2024.

On July 25, 2024, the parties contacted the hearing officer to request an extension of the stay in the remaining dockets until November 18, 2024. At that time the summary judgment motions in PCB 24-43 should be ready for a Board ruling. The request is granted, and the stay is extended to November 18, 2024.
