REQUEST FOR EXTENSION OF TIME TO FILE RECORD

Now comes Respondent, ILLINOIS ENVIRONMENTAL PROTECTION AGENCY (“Illinois EPA”), by KWAME RAOUL, Attorney General of the State of Illinois, and respectfully requests another forty-five (45) extension of time to file the record of Illinois EPA’s decision on the permit at issue in this case. In support of its request, Respondent states, as follows.

1. Petitioner filed the instant appeal on June 12, 2024. Pursuant to Section 105.116 of the Procedural Rules of the Illinois Pollution Control Board (“Board”).
2. On July 5, 2024, the Respondent Illinois EPA filed an unopposed motion for an extension of time to file the administrative record for this matter.
3. On July 8, 2024, the Hearing Officer granted Respondent Illinois EPA’s motion and ordered that the administrative record is to be filed by August 16, 2024.
4. An additional forty-five days is needed for Respondent Illinois EPA to adequately review the large number of documents, prepare and file the extensive record of its determination in this matter. Granting an extension will allow the Illinois EPA to complete this.
5. Petitioner has no objection to the additional extension.

WHEREFORE, Respondent ILLINOIS ENVIRONMENTAL PROTECTION AGENCY respectfully requests that the Board extend the deadline for filing the record of decision in this matter until September 30, 2024.
