AGREED MOTION TO EXTEND DISCOVERY

Ameren Energy Medina Valley Cogen, LLC ("Ameren") submits this Agreed Motion to Extend Discovery pursuant to 35 Ill. Adm. Code 101.522. In support thereof, Ameren states as follows:

- 1. On August 14, 2024, Ameren's Motion to Extend Discovery Period was filed, and on August 26, 2024, the Hearing Officer granted the unopposed motion, extending the discovery period to October 20, 2024.
- 2. There is good cause for the extension. After Ameren served the Illinois Environmental Protection Agency ("Illinois EPA") with interrogatories and requests for production, the Illinois EPA sought a 10-day extension of time to answer the interrogatories and respond to the requests, to which Ameren agreed. Illinois EPA answered Ameren's interrogatories on September 6, 2024, but sought a two-week extension to September 20, 2024, to respond to its requests for production, to which Ameren agreed. The Agency later requested one additional extension, to October 4, 2024, to provide its requests to produce responses, to which Ameren also agreed. On October 2, 2024, Illinois EPA provided its responses to Ameren's requests to produce.
- 3. To allow time to review the Illinois EPA's discovery answers and document production, and to arrange for depositions, if necessary, Ameren requests that the Hearing Officer extend the discovery deadline by 90 days, to January 18, 2025.

4. Illinois EPA has agreed to the 90-day extension.

WHEREFORE, Ameren Energy Medina Valley Cogen, LLC requests that the Hearing Officer grant its Motion to Extend Discovery by 90 days, to January 18, 2025
