MOTION FOR AN EXTENSION OF TIME TO FILE THE RECORD

- 1. On September 30, 2024, Dynegy Midwest Generation, LLC ("Petitioner") filed a Petition for Review of Illinois Environmental Protection Agency's Non-Concurrence with Alternative Source Demonstration Under 35 Ill. Adm. Code Part 845 and Motion for Stay, challenging a non-concurrence with an Alternative Source Determination issued by Illinois EPA to Petitioner on August 26, 2024.
 - 2. Respondent has no objection to Petitioner's requested stay.
- 3. Pursuant to Section 105.116(a) of the Board's regulations, 35 III. Adm. Code 105.116(a), the Illinois EPA must file the administrative record by October 30, 2024.
