**RESPONDENT’S UNOPPOSED MOTION FOR EXTENSION OF TIME TO RESPOND TO PETITIONER’S DOCUMENT REQUESTS**

NOW COMES Respondent, ILLINOIS ENVIRONMENTAL PROTECTION AGENCY (“Illinois EPA”), by and through the Attorney General of the State of Illinois (“AGO”), KWAME RAOUL, and pursuant to 35 Ill. Adm. Code 101.522 and 101.616, hereby moves for an extension of time until January 6, 2025 in which to serve Respondent’s Responses to Petitioner’s Document Requests. In support of this motion, the Respondent states as follows:

1. On September 9, 2024 the parties filed with the Board a proposed Agreed Written Discovery Schedule (“Discovery Schedule”).
2. On September 10, 2024, the Board hearing officer entered an order accepting the Discovery Schedule and ordering the parties to serve initial discovery requests by October 3, 2024 and to respond to discovery requests by November 7, 2024.
3. On October 3, 2024, Petitioner served Petitioner’s Document Requests to Illinois EPA.
