

**HEARING OFFICER ORDER**

On November 14, 2024, all parties participated in a telephonic status conference with the hearing officer. Discussions centered on the Board's order of August 22, 2024, regarding R23-18(A). In The Matter Of: Amendments To 35 Ill. Adm. Code 201, 2002, and 212, R23-18(A) (August 22, 2024). Petitioner noted that the order was published on September 13, 2024. The Illinois Environmental Protection Agency reported that the SSM/R23-18(A) will be addressed in their status approval process during Spring, 2025. Once complete, it will be forwarded to the USEPA for its review.

The parties or their legal representatives are directed to participate in a telephonic status conference on March 24, 2025, at 10:00 a.m. The telephonic status conference must be initiated by the petitioner and provide a call-in number, but each party is nonetheless responsible for its own appearance.

IT IS SO ORDERED.




