The Illinois Environmental Protection Agency ("Illinois EPA") hereby files its Recommendation pursuant to Section 125.204 of the regulations of the Illinois Pollution Control Board ("Board"), 35 Ill. Adm. Code 125.204.

The proposed water pollution control facilities in this request are located in the SW ¼ of Section 28, T9, R4 of the 4th P.M. in Henderson County, at the above street address and consist of the following livestock waste management structures:

One (1) concrete deep hog manure pit measuring 157 ft. (length) x 121 ft. (width) x 10 ft. (height) constructed of 8" thick concrete walls, approximately 18,997 sq. ft of concrete slatted flooring covering the entire pit (5 in. wide slats with 1 in. gap between slats), six (6) concrete pumpout ports measuring 6 ft. (length) x 6 ft. (width) x 8 ft. (depth), approximately 1,178 linear ft. of 6 in. (diameter) plastic drain tile and one 18" tall tile riser.

These livestock waste management facilities are used to collect, transport and/or store livestock waste prior to cropland application.

3. Section 11-10 of the Property Tax Code, 35 ILCS 200/11-10 (2022), and Section

125.200(a) of the Board's regulations, 35 Ill. Adm. Code 125.200(a), define "pollution

control facilities" as:

any system, method, construction, device or appliance appurtenant thereto or any portion of any building or equipment, that is designed, constructed,

installed or operated for the primary purpose of: eliminating, preventing, or reducing air or water pollution ...or treating, pretreating, modifying or

disposing of any potential solid, liquid or gaseous pollutant which if released without treatment, pretreatment modification or disposal might be harmful,

detrimental or offensive to human, plant or animal life, or to property.

4. In order to receive preferential tax treatment as pursuant to 35 ILCS 200/11-5 (2022),

pollution control facilities must be certified as such by the Board, 35 ILCS 200/11-20

(2022) and 35 Ill. Adm. Code 125.200(a).

5. Upon receipt of a tax certification application, the Illinois EPA must file a recommendation

on the application with the Board, 35 Ill Adm. Code 125.204(a).

6. Based on the information in the application and the purpose of the facility, it is the Illinois

EPA's engineering judgment that the described facilities may be considered "pollution

control facilities," pursuant to 35 Ill. Adm. Code 125.200(a), with the primary purpose of

eliminating, preventing, or reducing water pollution, or as otherwise provided in 35 Ill.

Adm. Code 125.200, and are eligible for tax certification from the Board.

WHEREFORE, the Illinois EPA recommends that the Board issue the requested



Below is the additional information you requested for reference to log number TC-147354

- 1. Attached is a site map of the location.
- 2. Described on site map. Stormwater drains north from the site to a waterway in the field that then is carried away in a creek that seasonally has water running. In the end it will end up in the Mississippi River which is roughly 12 miles away straight west.
- 3. Description: The control structure is a concrete pit with walls that are 8" thick. There is a concrete floor with walls that are 10 ft high and dimensions of 121'x157'. The entire pit is covered with concrete slats. The slats are 5" wide with a 1" gap for manure to pass through. The pit pump outs are built into the concrete pit which is a 6ft x 6ft square that is built into the pit with 8" thick walls and that are 8ft tall. There is no stationary pump to remove the manure and does not need to be included in this. The drain tile is 6" plastic tile that runs around the entire outside edge of the pit wall to capture water draining towards the pit. That perimeter tile comes into a 18" tile riser that comes to the surface so that water can be collected. Inside this tile riser is another tile that will then drain water to the waterway to the north to exit into the creek.
- 4. Original cost of the pollution control facility is \$243,245
