 - She (Cathy Aparo) keeps saying **you're wasting your place this time when they get better things to do than to deal with your bullshit.**
 - I think Cathy is behind it.
 - At one time she told Glenn (Pniewski) **"that nut job"** can't see something I don't know what they were talking about.
 - She only calls you **"the nut job"** when the Mayor is not around and leave it at that.
 - More people in the office are saying Cathy is losing it and she call you **"crazy she needs to be on meds or a strait jacket"**
 - Just talk that you were there & Cathy & Jeff went in her office a couple times came out laughing and saying **"must be a full moon tonight that you were out"**
 - Each morning, they report to Cathy.
 - He (Glenn Pniewski) is our gossip queen in the office.
