
**HEARING OFFICER ORDER**

On January 2, 2025, all parties participated in a telephonic status conference with the hearing officer. On December 31, 2024, respondent filed a motion for an extension of time to file the record in this appeal, to March 4, 2025. Petitioner had no objection. Respondent's motion is granted. Petitioner's motion to consolidate With PCB 25-9 is under review by the Board.

Petitioner stated that it will file an additional waiver of the statutory decision deadline to a date certain or an open waiver within 7 days.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on April 3, 2025, at 10:15 a.m. The telephonic status conference must be initiated by the petitioner, and provide a call-in number, but each party is nonetheless responsible for its own appearance.
